



Notification of Updating <Tariff of Accounts and Services for Wealth and Personal Banking Business>

Dear Customer:

The "Tariff of Accounts and Services for Wealth and Personal Banking Business" has been updated and it will come into effect on 8 Aug 2025. The updates are:

1. 2.2.6.1 "Fund transfer to self-name HSBC accounts in other countries/ territories via HSBC Global Transfer" is planned to increase the fee for Advance customers on 10 Nov 2025, with a new fee standard of RMB145.00 per transaction (This is an indication charge, the actual charge per transaction will be USD20 or equivalent in other foreign currency). The specific effective time will be announced separately by public notice later.
2. 2.2.3.8 "Cross Branch Services within HSBC China: Issue Certificate of Balance" is planning to lower the service fee for Advance to CNY25 / equivalent per copy.
3. 2.2.3.1 "Cross Branch Services within HSBC China: Foreign Currency Notes Withdrawal" is planning to unify the service fee for Advance to "0.25% of the withdrawal amount, Min. CNY40 / equivalent per transaction, Max. CNY200 / equivalent per transaction"; and for Personal Banking to "0.25% of the withdrawal amount, Min. CNY40 / equivalent per transaction, Max. CNY200 / equivalent per transaction" and waive the "Cross Branch Service Charge CNY100 / equivalent per transaction".
4. 2.2.2.1 "Foreign Currency Notes Withdrawal Over Counter, Currencies Available: USD, HKD, JPY, EUR (For exact foreign currency cash availability, please check with your nearest local branch)" is planning to unify the service fee for Personal Banking to "0.25% of the withdrawal amount, Min. CNY40 / equivalent per transaction, Max. CNY200 / equivalent per transaction".
5. 2.2.3.2 "Cross Branch Services within HSBC China: Foreign Currency Cash Deposit" is planning to waive "Cross Branch Service Charge CNY100 / equivalent per transaction" for Personal Banking.
6. 2.2.3.4 "Cross Branch Services within HSBC China: Foreign Currency Fund Transfer within HSBC China" is planning to waive service fee for Advance and Personal Banking.
7. 2.2.8.2 "Remittances under HSBC GBA Northbound/Southbound Wealth Management Connect Service: Outward Remittance (including Electronic Banking Service)" is planning to waive service fee for Premier and Advance customers. The campaign of "Customers will enjoy the benefit of service fee exemption until 18 Oct 2025" will end at the same time.
