



Notification of Updating <Tariff of Accounts and Services for
Wealth and Personal Banking Business>

Dear Customer:

The align with business adjustment, some items of "Tariff of Accounts and Services for Wealth and Personal Banking Business" will be updated on 29 Sep 2026. The tariff items for USD service via CFXPS will be revised as follows: 1) Revision: USD Remittance/Amendment/Enquiry/Cancellation via CFXPS, the charge will be adjusted from CNY20/equivalent per transaction to CNY30/equivalent per transaction; 2) Adding: Return inward USD remittance via CFXPS: CNY20/equivalent per transaction.

CFXPS stands for China Foreign Exchange Payment System and is established and operated by People's bank of China Payment and Clearing Center for domestic foreign currency payment service.

- 1. "Via Local Clearing" and "Amendment, Enquiry or Cancellation at the customer's request" is planned to change the fee for Private Banking/Premier/Advance customers on 29 Sep 2026 and revise the associated descriptions and remarks accordingly.**
