# Important interest rate changes are happening in 2021. Here's what that means for you

重要的利率变更将在 2021 年发生, 这里是您需要知道的信息

Financial institutions all over the world are getting ready for a change in how they set some of their interest rates and prices. Since this might affect your HSBC products and services in a number of ways, we wanted to let you know what we're doing to prepare.

### What's changing?

Products such as loans, mortgages, structured products, bonds and other financial products often use 'reference rates' such as the London Interbank Offered Rate (LIBOR) to set the applicable interest rates and payment obligations. Regulators in several countries have been looking at LIBOR and other Inter-Bank Offered Rates (IBORs) to decide whether these rates should be replaced by alternative 'risk-free rates'. We expect these changes to be complete by the end of 2021.

#### 改变具体是什么?

诸如贷款,放贷,结构性产品,债券和其他金融产品之类的产品通常使用"参考利率",例如伦敦银行间同业拆借利率(LIBOR),来设置适用的利率和支付义务。部分国家/地区的监管机构正在研究 LIBOR 和其他银行间同业拆借利率(IBORs),以决定是否应使用其他"无风险利率"来代替这些利率。 我们预计这些变化将在 2021 年底前完成。

#### What does this mean for you?

The Overseas Investment Plan - Offshore Fund you hold may references LIBOR in its prospectus, for example in its investment objectives. This may be because the fund is benchmarked against the performance of LIBOR, because it uses LIBOR as a yield target [or where there are performance fees linked to LIBOR]. ## 对于您来说意味着什么?

### What will happen next?

We are working with our regulators and industry groups and are actively monitoring developments. At the moment, it is not possible to confirm what the impact on your product will be as the industry continues to prepare for the introduction of the new rates and the impact of the changes.

You'll likely see IBOR reforms in the news over the next few months so we wanted to let you know that we're getting ready for the changes. We'll contact you as soon as we have more details for how the changes will affect you, or you may get the notice from fund manager. 接下来的安排是什么?

我们正在与监管机构和行业团体合作,并积极监测发展情况。目前由于行业仍在继续为引入利率和这一变更所带来的影响做准备,因此尚无法确定对产品的影响。
