1. I/We confirm that the information contained in this form is true, accurate and up-to-date, and authorize you (the "Bank"), through any of its branches and sub-branches, to refer to any source to verify such information. I/We agree that such information will be used for this application for account opening and other purposes that the Bank deems appropriate, including without limitation, the purposes set out in the General Terms and Conditions (For Personal Sole Account, Joint Account and Business Account Holders) (the "Terms").
